| <p><b>The only other mined areas that contain, or are suspected to contain, anti-personnel mines under the jurisdiction of the Republic of Cyprus are located in the areas north of the buffer zone, which are occupied by Turkey. As reported within the request submitted by Cyprus for an extension of the deadline to fulfill its obligations under Article 5.1 (a request which was approved by the Twelfth Meeting of the States Parties), 21 minefields laid by Turkey's occupational forces are known not yet to be cleared of anti - personnel mines. These are overwhelmingly situated adjacent to the buffer zone. Precise information on their size, on their composition (whether they include mines other than anti - personnel mines) and on how much land can be safely treated as arable when these mines have been cleared is unknown. Furthermore, before and during the invasion of 1974, the National Guard laid 28 minefields north of Nicosia towards the Pentadaktylos mountain range, which are today located in the Turkish - occupied areas. The latter minefields included 1006 anti - personnel mines, but the Republic of Cyprus is not aware of the current condition of these minefields and whether they have been cleared by the Turkish occupational forces or not.</b></p> <p><b>So far as the Government of Cyprus is aware, there has been no progress in the clearance of mined areas under the control of the Turkish occupational forces. Mine clearance in the occupied part of the Republic involves the legal responsibility of Turkey as a State Party to the Ottawa Convention and to the CCW and its Protocols.</b></p> |      |          |                     |                           |

**Form I Measures to provide warning to the population**

Article 7.1 "Each State Party shall report to the Secretary-General ... on:

- i) The measures taken to provide an immediate and effective warning to the population in relation to all areas identified under paragraph 2 of Article 5."

*Remark:* In accordance with Article 5, para.2: "Each State Party shall make every effort to identify all areas under its jurisdiction or control in which anti-personnel mines are known or suspected to be emplaced and shall ensure as soon as possible that all anti-personnel mines in mined areas under its jurisdiction or control are perimeter-marked, monitored and protected by fencing or other means, to ensure the effective exclusion of civilians, until all anti-personnel mines contained therein have been destroyed. The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects".
