Agreement between the States Parties to the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on their Destruction and the Geneva International Centre for Humanitarian Demining (GICHD) on implementation support for the Convention

REPORT ON THE IMPLEMENTATION OF THE AGREEMENT BETWEEN THE STATES PARTIES TO THE CONVENTION ON THE PROHIBITION OF THE USE, STOCKPILING, PRODUCTION AND TRANSFER OF ANTI-PERSONNEL MINES AND ON THEIR DESTRUCTION AND THE GENEVA INTERNATIONAL CENTRE FOR HUMANITARIAN DEMINING (GICHD) ON IMPLEMENTATION SUPPORT FOR THE CONVENTION, FOR THE YEAR 2011.

## 1. Infrastructure, administrative and other support

In 2011, the GICHD provided general administrative support to the ISU-APMBC, Human Resources management (including insurances), financial management (in particular for the trust funds ISU-APMBC and APMBC Sponsorship Programme), contract and document management (Sharepoint), office rent and supplies, ICT (hardware, software, maintenance and telecommunication costs), travel services, publications and website management. The expenditures/costs of this administrative and logistical support have been tracked and amount to approximately 315,000 CHF.

The GICHD also supported the ISU-APMBC in the organisation of the intersessional work programme and the administration of the sponsorship programme. The expenditures/costs to the GICHD of hosting the intersessional meetings of the APMBC Standing Committees at the GICHD, including conference management, conference room rental and interpretation (English, French, Russian, Spanish), amount to approximately 150,000 CHF for 2011. The expenditures/costs of administering the APMBC Sponsorship Programme, including travel and accommodation services as well as reporting and auditing amount to approximately 45,000 CHF. In 2011, the programme sponsored 100 participants to attend the Meetings of the Standing Committees from 20 to 24 June 2011 and the Eleventh Meeting of the States Parties (11MSP) from 27 November to 2 December 2011 with a total expenditure of 308,000 CHF.

In total, the GICHD support for 2011 amounts to approximately 510,000 CHF which was charged to the Swiss core contribution 2011 to the GICHD.

## 2. ISU-APMBC staff

During 2011, the following ISU-APMBC staff members were under GICHD contract (salaries, where applicable, were paid from the Trust Fund ISU-APMBC):

- Ms Bérénice Schramm, Implementation Support Officer, 100% from 13 to 27 January, 100% from 14 June to 22 July, 50% from 19 September to 11 November
- Ms Laila Rodriguez, Volunteer, 20%, from 23 March to 30 June 2011

The Director of the ISU-APMBC and the Mine Action Implementation Specialist has (February 2012) or will have soon (July 2012) reached 10 years' employment at the GICHD.

For the Mine Action Implementation Specialist, this raises the issue of the contract duration and the related paragraph of the GICHD Internal Rules and Regulations: 'Rotation of expert staff shall be encouraged to ensure that staff are up-to-date with trends in the field and with other organisations, and can bring fresh ideas and enthusiasm with them. It is not envisaged that any expert staff member would work at the GICHD for more than 10 years.' The Director of the GICHD and the Director of the ISU-APMBC came to the conclusion that this rule does not apply to the ISU-APMBC Mine Action Implementation Specialist because her tasks are not related to 'field experience' but rely on continuity.

The Director of the GICHD asked the President of the APMBC States Parties for guidance with regard to the tenure period of the Director of the ISU-APMBC. In the absence of a response, the Director of the GICHD assumes that the APMBC States Parties do not wish that there are any time limitations to the contract with the Director of the ISU-APMBC.

## 3. Trust Funds ISU-APMBC and APMBC Sponsorship Programme

In 2011, the GICHD administered the ISU-APMBC funds according to the agreement on GICHD's implementation support for the APMBC.

All financial contributions intended for the ISU-APMBC were credited to the 'Trust Fund ISU-APMBC' bank account. Contributions to the sponsorship programme were credited to the 'Trust Fund APMBC Sponsorship Programme' bank account. The GICHD internal control system was applied for all expenditures of the two trust funds; no financial irregularities were noticed.

The Trust Fund ISU-APMBC and the Trust Fund APMBC Sponsorship Programme were audited by Deloitte SA. The audit reports were submitted by the Director of the GICHD to the President of the Meeting of the APMBC States Parties.
