PRELIMINARY OBSERVATIONS ON THE IMPLEMENTATION OF ARTICLE 5 BY THE STATE OF PALESTINE

I. Progress in implementation (OAP Action #8, #20, #22)

- 1. The State of Palestine reported progress in implementation for the period 2016 2023. The State of Palestine reported for the period 2015-2022 it addressed a total of 17 tasks measuring 237,888 square metres through clearance in 5 districts, in the process destroying 958 anti-personnel mines, 159 anti-tank mines, 16 items of unexploded ordnance and 120 DR(?).
- 2. The State of Palestine also reported in 2023, it addressed 2 tasks in the district of Jenin and 2 tasks in the Jordan Valley district measuring 85,629 square metres, in the process destroying 33 anti-personnel mines, and 26 anti-tank mines. The State of Palestine also reported addressing 4 tasks measuring 213,788 square metres in the Jordan Valley, and 8 tasks measuring 109,186 square metres in the compounds of Churches.
- 3. The State of Palestine reported that the sole circumstance that impeded its ability to destroy all anti-personnel mines in mined areas reported to be under its jurisdiction or control namely that it did not have effective control over the remaining areas in question.
- 4. The Committee observed that the information provided by State of Palestine on progress in implementation allowed for some comparability with that previously reported. The Committee welcomed the State of Palestine providing information on progress in accordance with land release methodology employed, in accordance with the International Mine Action Standards (IMAS) and disaggregated by type of contamination. The Committee further encourages the State of Palestine to report employing the Guide to Reporting. (Action #8, Action #22)

II. Clarity regarding remaining challenge (OAP Action #18, #22)

5. The Committee observed that the State of Palestine provided some clarity¹ concerning its remaining challenge (Action #18). The State of Palestine reported a remaining challenge of 65 suspected mined areas located on the border with Jordan measuring 18,510,889 square metres, and in 2023, like that in 2012, 16 known mined areas measuring 604,634 square metres remain to be addressed. The Committee observed that the State of Palestine reported that the sole circumstance that impeded its ability to destroy all anti-personnel mines in mined areas reported to be under its

- jurisdiction or control namely that it did not have effective control over the remaining areas in question. (Action #22)
- 6. The Committee welcomed the State of Palestine reporting on its remaining challenge in a manner consistent with the IMAS by providing information disaggregated by suspected hazardous areas and confirmed hazardous areas. (Action #22)
- 7. The Oslo Action Plan (OAP) requests States that have not yet done so to identify the precise perimeter of mined areas, to the extent possible, and establish evidence based, accurate baselines of contamination based on information collected from all relevant sources, no later than by the Nineteenth Meeting of the States Parties in 2021. The Committee observed that the State of Palestine was still in the process of identifying the precise perimeter of mined areas and that the sole circumstance that impeded its ability to destroy all anti-personnel mines in mined areas reported to be under its jurisdiction or control namely that it did not have effective control over the remaining areas in question. (Action #18)
- 8. The OAP requests States to report on having established their baseline through inclusive consultations with women, girls, boys and men. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #18)

III. National plans for clearance and survey (OAP Actions #1, #2, #3, #6, #19, #20, #26)

- 9. The OAP requests States to develop evidence-based, costed and time-bound national strategies and work plans to fulfil and implement Convention obligations as soon as possible. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #2)
- 10.The OAP requests States to develop evidence-based and costed national work plans, including projections of the number of areas and the amount of mined area to be addressed annually to achieve completion as soon as possible, and no later than their Article 5 deadline, to be presented at the Eighteenth Meeting of the States Parties in 2020. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #19)
- 11. The Committee observed that the State of Palestine reported annual updates to their national work plan based on new evidence and reported on adjusted milestones including plan to address 4 tasks measuring 373,512 square metres in the Jordan Valley. (Action #20)
- 12. The State of Palestine reported an annual national financial contribution towards implementation, including being responsible for the funding of the Palestine Mine Action Centre headquarters and salaries of its staff (Action #1).
- 13. The OAP requests States to demonstrate high levels of national ownership, including by integrating Convention implementation activities into national development plans, poverty reduction strategies, humanitarian response plans and national strategies for the inclusion of persons with disabilities as appropriate. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #1)
- 14. The Oslo Action Plan requests States to strengthen partnerships and integrate responses between the mine action community and relevant humanitarian, peacebuilding, development and human

- rights communities, bearing in mind the 2030 Agenda for Sustainable Development. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #6)
- 15. The Oslo Action Plan requests States to ensure that the different needs and perspectives of women, girls, boys and men are considered and inform all areas of Convention implementation and mine action programmes, in order to deliver an inclusive approach. Strive to remove barriers to full, equal and gender balanced participation in mine action and in Convention meetings. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #3)
- 16. The OAP requests States to ensure that national strategies and work plans for completion make provisions for a sustainable national capacity to address previously unknown mined areas, including newly mined areas discovered following completion. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #26)

IV. Efficient and expedient implementation (OAP Actions #5, #9, #27)

- 17. The OAP requests States to keep national mine action standards up to date in accordance with the latest International Mine Action Standards (IMAS), adapt them to new challenges and employ best practices to ensure efficient and effective implementation. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #5)
- 18. The OAP requests States to establish and maintain a national information management system containing accurate and up-to-date data at the national level on the status of implementation. The design and implementation of information management systems will ensure that they are nationally owned, sustainable and take into account the need for data that can be accessed, managed and analysed post-completion. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #9)
- 19. The OAP requests States to take appropriate steps to improve the effectiveness and efficiency of survey and clearance, including by promoting the research, application and sharing of innovative technological means to this effect. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #27)

V. Mine risk education and reduction (OAP Actions #28-32)

- 20. The Committee observed that the State of Palestine reported on mine risk education and reduction activities for the period 2017-2024. T The State of Palestine reported on its efforts to effectively exclude the population from mined areas, including the marking of mined areas and use of warning signs in Arabic, English and Hebrew languages, and that the signs are maintained and replaced periodically, and that awareness teams make visits to the most vulnerable populations, including the methodologies used, including lectures, electronic presentations, illustrations, and other awareness materials and with results achieved disaggregated by gender and age. (Action #32)
- 21.The OAP requests States to integrate Mine Risk Education and Reduction (MRE/R) with wider humanitarian, development, protection and education efforts, as well as with ongoing survey and clearance activities. The Committee would welcome further information on the State of Palestine's

efforts to integrate MRE/R into wider humanitarian, development, protection and education. (Action #28)

- 22. The OAP requests States to provide context-specific MRE/R for all affected populations and groups at risk. To ensure if such programmes are developed on the basis of a needs assessment and that they are tailored to the threat encountered by the population, and are sensitive to gender, age, disability and take the diverse needs and experiences of people in affected communities into account. The Committee observed that while the State of Palestine reported that despite a lack of human and logistical resources to implement these important campaigns. That the staff of the PMAC have made efforts to raise awareness of the dangers of mines and explosive remnants of war in various Palestinian governorates and for different segments of the population, and that according to the strategic plan of the PMAC, financial, logistical and staffing support will be provided to complete awareness-raising activities for at least 60% of Palestinian communities adjacent to minefields and training areas by 2023, and for at least 85% by 2024. The Committee observed that the State of Palestine had not provided information in its Article 7 Report on its efforts to ensure if such programmes are developed on the basis of a needs assessment, and are sensitive to gender, age, disability and take the diverse needs and experiences of people in affected communities into account and would welcome further information in this regard. (Action #29)
- 23.The State of Palestine reported that by the end of 2026, PMAC will have expanded its coverage in collecting data and managing information on individuals killed or injured by mines or remnants of war to include all northern governorates and have also collected information on approximately 90% of individuals killed or injured by mines or explosive remnants of war. The State of Palestine also reported that while the Palestinian Ministry of Health's Ambulance and Emergency Unit registers occupation-related injuries in general, it has not yet included "anti-personnel mines/other ERW" as one of the causes of injuries, however, studies will be conducted on indirect victims of minefields and all Palestinian communities adjacent to minefields. The Committee welcomes the updated information from the State of Palestine and encourages the State of Palestine to continue to report information on the implementation of Action #30, respectfully. (Action #30)
- 24. The OAP requests States to build national capacity to deliver mine risk education and reduction programmes with the ability to adapt to changing needs and contexts, including the delivery of such programmes to affected communities in the case that previously unknown mined areas are discovered. The Committee observed that the State of Palestine had not provided updated information in its Article 7 Report in this regard and would welcome further information. (Action #31)

VII. Challenges in implementation (OAP Action #8)

25.The Committee observed that the State of Palestine provided quality information on challenges in implementation, including, a lack of human resources for survey, and clearance and risk education activities, and a lack of equipment used to support survey, clearance and risk education activities, a lack of medical staff specialised in treating injuries caused by mines and remnants of war, and a lack of information and statistics related to the victims of mines and explosive remnants of war. (Action #8).
