STATUS OF IMPLEMENTATION – VICTIM ASSISTANCE

COMMITTEE ON VICTIM ASSISTANCE

(Burkina Faso, the Netherlands, Slovenia (Chair) and Zambia)

Intersessional Meetings

18-20 June 2024

1. The Committee welcomes the submission by Angola of updated information on its victim assistance activities.
2. Based on the information provided in Angola's Article 7 report, the Committee presents the following preliminary observations.

Mine casualties

1. Angola reported 83 new casualties in 2023 including 47 wounded and 36 killed, showing a significant increase to 35 casualties in 2022. Angola provided disaggregated information on casualties by gender and age, which shows that in 2023 64% of casualties were children including 8 girls and 24 boys killed, 6 girls and 15 boys wounded.

VICTIM ASSISTANCE ACTIONS:

Strengthen partnerships and integrate victim assistance into broader national policies, plans and legal frameworks and designation of a government entity to oversee the integration (Action 33 and also Actions #1 and #6)

2. The Committee recalls that Angola had reported that victim assistance was primarily implemented by the National Intersectoral Commission for Demining and Humanitarian Assistance (CNIDAH) which has been recently abolished and replaced by the National Demining Centre (CND), the only national government operator that operates under the Angola's National Mine Action Agency (ANAM).
3. Also, the Committee recalls that in the past Angola reported that the Ministry for Social, Family of Women's Affairs (MASFAMU) is responsible to meet the needs and rights of persons with disabilities including mine survivors, while the Ministry of Former Combatants and Veterans of War (MACVP) provided assistance to military and police veterans.
4. The Committee would welcome an update on the role of the ANAM and relevant ministries in overseeing the integration of victim assistance into broader national frameworks. The Committee would further welcome information on progress made in strengthening coordination and collaboration in this regard.

Develop and implement measurable, realistic and time-bound national action plan (Action #33 and also Action #2)

5. Angola reported that since 2022, ANAM collaborated with its partners and stakeholders to develop a national mine action standard (NMAS) in accordance with the International Mine Action Standard (IMAS) on Victim Assistance (IMAS 13.10) and that the NMAS will be approved soon.

6. The Committee would welcome information on the development / implementation of a national action plan that facilitates the implementation of victim assistance in Angola.

Removing barriers including physical, social, cultural, political, attitudinal and communication barriers to access such services (Action #33)

7. The Committee would welcome information on efforts made in 2023 to address any barriers that hamper participation and inclusion of mine victims on equal basis with other members of their society.

Applying multi-sectoral efforts to ensure that the needs and rights of mine victims are effectively addressed in line with the Convention on the Rights of Persons with Disabilities (Action #34)

8. Angola reported that ANAM worked in collaboration with relevant government agencies and other stakeholders to develop a NMAS on victim assistance. Angola reported that ANAM works with civil society organisations and churches and include them in planning, implementation and evaluation activities.
9. The Committee would welcome updates on efforts made to address the challenges in applying a multi-sectoral approach and information on alignment of victim assistance activities with the provisions of the Convention on the Rights of Persons with Disabilities (CRPD).

Establish or strengthen of a centralised database / national information management system (Action #35 and also Action #9)

10. The Committee would welcome information on availability of, or progress made in establishing of a centralised database including information on persons killed or injured by mines and their needs and challenges, disaggregated by gender, age and disability.

Access to first aid and ongoing emergency medical care (Action #36)

11. Angola reported that progress was made in health sector including through construction of new health care centres, upgrading of equipment and training of relevant staff members.
12. The Committee would welcome an update on progress made to increase first aid and ongoing emergency medical care in affected areas, and efforts made to provide pre-hospital care to new casualties in 2023.

Developing national referral mechanism (Action #37)

13. The Committee recalls that in 2020 Angola reported that a referral system has been in place within primary healthcare and that a national directory of services will be developed, subject to availability of resources. The Committee would welcome an update in this regard.

Access to rehabilitation services including physiotherapy, assistive devices and occupational therapy (Action #38)

14. Like in 2023, Angola reported that progress has been made in the healthcare sector with the construction of new health facilities and the rehabilitation of existing centres, to assist people with disabilities [including mine victims]. Angola reported that orthopaedic centres are in full operation

and although they have benefited from refurbishment services, some need more attention in terms of maintenance, while others are equipped with “state-of-the-art materials”.

15. Angola reported that efforts were made to improve rehabilitation including by strengthening rehabilitation technicians capacities.

Access to psychological and psychosocial services including peer-to-peer support (Action #38)

16. The Committee would welcome information on progress made in providing psychological and psychosocial including peer to peer support to mine victims in 2023.

Access to social and economic inclusion services, including in rural and remote areas (Action #39)

17. Like in 2023, Angola reported that the strengthening of social protection (known as “KWENDA” in Portuguese) and informal economy conversion (known as “PREI” in Portuguese) programmes implemented by the government have contributed to the well-being of the population. Angola reported that new schools and hospitals have been built. Angola further indicated that roads have been built or rehabilitated outside these locations to facilitate access for people living in remote areas and to enable more women and children to be enrolled in the education system.

18. Angola reported that in the field of social inclusion, people with disabilities participate in sports such as: football with crutches, wheelchair basketball, athletics, etc.

19. The Committee recalls that in 2023 Angola reported that efforts were made to ensure people with disabilities are integrated into the employment system through recruitment and selection processes based on Presidential Decree No. 12/16. Angola reported that this decree ensures that 4% of employees of government institutions and 2% of employees of private institutions are persons with disabilities.

Taking measure for safety and protection of mine survivors in situations of risks and emergencies (Action #40)

20. The Committee recalls that in 2020 Angola reported that safety and protection of people in situations of disaster is part of the Civil Protection Commission’s mandate.

21. The Committee would welcome information on measures in place through the Civil Protection Commission or other entities to ensure the safety and protection of mine survivors in situations of risks and emergencies.

Strengthening inclusion and participation of mine victims and their representative organisations in all matters that affect them (Action #41 and also Action #4)

22. The Committee recalls that Angola had reported that mine survivors and their representative organisations had been included in relevant programmes and policies, except in rural and remote areas and that more would need to be done to implement national laws with regards to participation and inclusion of mine survivors.

23. The Committee would welcome an update in this regard.

CROSS-CUTTING ACTIONS:

Demonstrate high levels of national ownership, including [...] by making financial and other commitments to implementation (Action #1)

24. Angola reported efforts in implementing this aspect of the OAP including the development of a national standard to strengthen national efforts in victim assistance.

25. Angola also reported allocating national funds to ANAM which leads coordination of mine action programme including victim assistance efforts.

26. The Committee would welcome information on financial or other commitments Angola made to address the needs of mine victims.

Ensure that the different needs and perspectives of women, girls, boys and men are considered (Action #3)

27. Angola included disaggregated data on mine casualties in 2023, in its Article 7 Report.

28. The Committee would welcome additional information on progress made and/or measures put in place to ensure gender equality and diversity in victim assistance activities.

Challenges in implementation of Victim Assistance Commitments (Action #8)

29. Angola reported facing constraints in financial resources that continued to affect victim assistance implementation. The Committee would welcome information on how the international community could be of further support to Angola's efforts in fulfilling its victim assistance commitments under the Convention and the OAP.
