Private Sector Partnership Towards A Mine-Free World

This side event will highlight and promote the private sector's contribution to mine action through financial support, technological innovation, strategic partnership, and advocacy, and how to foster greater private sector collaboration in order to achieve a mine-free world.

Beyond Completion: Residual Risk and Sustainable National Capacities

Zambia Mine Action Centre (ZMAC) and the Mines Advisory Group (MAG)

This side event will explore key considerations for States Parties on the path towards and beyond completion, drawing on lessons learned from the Republic of Zambia. Zambia declared completion of its Article 5 obligations in 2009. Reflecting the strong national commitment to humanitarian disarmament, the Zambia Mine Action Centre (ZMAC) has remained an active entity, coordinating the cross-Ministerial response to residual contamination and engaging a network of volunteers in community liaison activities. Zambia has also maintained active engagement with Convention machinery, including chairing the Article 5 Committee during the 19MSP, and currently a member of the Victim Assistance Committee. In 2026, Zambia will take on the Presidency of the Convention. ZMAC has worked closely with MAG to analyse good practices, lessons learned, and challenges gained. This event will be an opportunity to share these insights with fellow states parties, discuss its implications, and provide recommendations towards areas of focus for the Siem Reap-Angkor Summit on a Mine-Free World.

Shifting the Status Quo: Challenges and Opportunities in Afghanistan

Humanity and Inclusion

This side event will share the findings of a recent case study developed by Humanity & Inclusion (HI) that identifies the segment of the population in need of Humanitarian Mine Action (HMA) in Afghanistan and the challenges and opportunities in delivering effective HMA to this population. The study also explores the country's recent context in which, without adaptability from key decision-makers, the opportunity to shift the status-quo may be lost forever. In addition to HI, panelists, including the Landmine and Cluster Munition Monitor will present on the current level of contamination, the Ministry of Foreign Affairs of Norway will share experiences and the need for funding, and the Danish Refugee Council will share examples from its HMA work in Afghanistan. Greening Mine Action and Convention implementation

This side event will explore five ways in which survey and clearance programmes can take the environment and climate change into consideration during survey and clearance efforts. These include adopting environmental management policies and national mine action standards; conducting environmental assessments and implementing mitigation measures; and taking climate-related risks into account during planning and prioritisation efforts. Chaired by the United Kingdom's Foreign, Commonwealth, and Development Office (FCDO), panelists will also outline possible ways to incorporate climate and the environment into the Siem Reap-Angkor Action Plan in preparation for the Fifth Review Conference.

Representatives from the Gender and Diversity Working Group (GDWG) and the Netherlands, serving as one of the four APMBC Gender Focal Points, will discuss progress since the Oslo Review Conference (2019) and explore ways to enhance gender and diversity mainstreaming, ahead of the Fifth Review Conference.
